## IRHA Preferred Supplier Programme 2018-19

### About the IRHA

The IRHA is the recognised national representative body of the licensed road haulage industry in the Republic of Ireland.

IRHA members operate under Road Haulage Operator Licences issued by the Department of Transport. A Road Haulage Operator's Licence is required where goods are carried for hire or reward in a vehicle or combination of vehicles which is in excess of 3.5 (metric) tonnes.



The IRHA was founded in 1973 with the purpose of representing and promoting the interests of Ireland's licensed road haulage industry – on a national and international level. The Association promotes professionalism, excellence and safety in the operation of road transport businesses.

### The Opportunity

There are 4,500 licensed hauliers in Ireland employing approximately 30,000 people. In an average year, IRHA members operate 9000 vehicles on a national and pan-European basis, spending considerable sums on telecommunications, insurance and fuel to name just a few factors.



Irish licensed hauliers operate numerous warehouses, each requiring power, facilities, maintenance and general supplies.

Haulage companies looking for suppliers regularly contact the IRHA for recommendations and until now the IRHA has had no formal approval process. As of July 2011, the IRHA adopted a formal approval process for Preferred Suppliers. We have two categories within the Preferred Supplier Programme; Corporate Partner and Patron.

By becoming a Preferred Supplier to the Irish Road Haulage Association, you will become an approved supplier to the licensed haulage industry in Ireland. Corporate Partners will enjoy exclusivity in their particular supplier category with the recommendation of no other provider. In the Patron sector we will select a maximum of three suppliers for each category and the list of preferred suppliers will be distributed to the haulage industry by the IRHA. When we have received three suppliers in a category we will close that category until the following year. Both of the above categories will operate on a first come first served basis.

1. Reduce Risk: Members are assured that the Irish Road Haulage Association has fully investigated each listed company by checking references, company history and financial stability.
2. Save time and expense: Members can identify reliable suppliers with a track record of quality by simply consulting with the IRHA head-office, our monthly newsletter or the IRHA website.
3. Support those who support the work carried out by the Irish Road Haulage Association on their behalf.
4. IRHA members are informed of partners in industry who are seeking to assist the IRHA's objective of promoting professional development in the sector.



The Irish Road Haulage Association officially launched the 'Preferred Supplier Directory' in July 2011 amongst its membership, highlighting the rigorous vetting process and reinforcing the benefits to members of dealing with pre-qualified suppliers.



## Who Can List as a Preferred Supplier?

Any supplier to the trade may apply to be a Corporate Partner or Patron of the Association. Only those companies which pass a rigorous vetting process are invited to list as Preferred Suppliers. The Irish Road Haulage Association will carry out an annual review of the service provided to members by each of our Corporate Partner & Patron Listing. Any member complaints will be fully investigated and companies are de-listed if substandard service is provided.



## Application Process

- Complete an IRHA 'Preferred Supplier Application Form'.
- Include one trade reference from an IRHA member.
- Return Application Form to IRHA HQ - FAO Jonathan.
- Once your application form is received, your company information and references will be checked and you may be contacted again if further information is required.
- If approved, you will be asked to submit the appropriate fee and a copy of your logo.
